## Great American Outdoors Act Passes U.S. Senate!



In an overwhelming bipartisan show of support, and after many procedural votes, the U.S. Senate just passed the [Great American Outdoors Act](#) with a vote of 73-25. The bill includes full and permanent funding for the Land and Water Conservation Fund (LWCF) and addresses priority repair needs in our national parks and other land management agencies.

The bill will likely be voted on in the US. House of Representatives soon - likely before the July 4th Recess.

### **Mountain Pact Reacts to the Great American Outdoors Act Passing in the Senate, Calls on the House to "Get This Done"**

*Critical Investment in Jobs, the Economy, and Our Public Lands Advances*

Durango, CO -- In response to the Senate passing the Great American Outdoors Act, bipartisan legislation that will fully and permanently fund the Land and Water Conservation Fund (LWCF) today, The Mountain Pact gave these statements:

said, "Public lands, parks, and trails are vital to restoring our country's health and way of life amidst the COVID-19 pandemic. We thank the Senate for passing The Great American Outdoors Act and now urge the

House of Representatives to quickly follow suit and move to have it signed by the president."

**Mayor of Bozeman, Montana, Chris Mehl**, said, "Our public lands generate economic revenue and bring us peace of mind - both are critically important to recover from the impact of the COVID-19 outbreak. The Great American Outdoors Act will help sustain many of our small towns and businesses who rely on outdoor recreation to thrive; House of Representatives, we call on you to get this done."

**Mayor of Carbondale, Colorado, Dan Richardson**, said, "Originally a bipartisan initiative, LWCF has continued to have the support of lawmakers from both sides of the aisle for decades, proving that supporting public lands isn't political, it is just common sense. We are thankful to the U.S. Senate for passing the Great American Outdoors Act and look now to the House of Representatives to take similar action and pass this onto the president's desk as quickly as possible."
